• 110 White's Road to renew permit to operate a domestic saw mill for personal use, subject to operation and maintenance of sawmill in accordance with provincial guidelines and regulations; sawmill to be operated within the accessory building on the property to reduce noise during operation.

The CAO noted that this has to come back annually to be renewed so Council can ensure there are no concerns with the operation.

Another application for a temporary storage shed for winter was reviewed. The portable shelter does not meet the minimum 1.5m sideyard requirement. The actual measurement is 0.6m. Per the survey attached, it appears there maybe space to relocate the shed to meet the regulations. The committee recommends to complete further review of the application to determine if the storage shed can be placed on the property in compliance with the Development Standards before refusing the application.

<u>Water Street property</u>, Request for extension to keep the greenhouse on the property until the spring.

The committee recommends to approve the request to allow the greenhouse placed to remain on the property situate at 180 Water Street until the spring at which time the permit holder will have to remove or relocate if the greenhouse is outside the property boundary.

Gould's Lane, issue regarding fence on property

The Director of Operations has been speaking to the property owner and permit holder and have come to an agreement on the matter.

Wexford Road, Motion for refusal

Previously we reviewed a permit application and didn't approve it, however a refusal motion is required for an application that is not approved.
