Special Meeting of Council was called by Mayor Butt. Mayor Butt called the meeting to order at 9:30 am.

1. Application for Funding under the FCM Municipal Asset Management Program Funding

CAO noted that the funding is on an 80/20 basis with FCM funding up to \$50,000. The Town has to contribute \$10,000. There will be other contributions in kind as staff will be part of this as well so we can include staff wages and expenses as inkind but those funds are not eligible for funding. All managers will be part of this process. The plan is to use the \$50,000 to hire a consultant to assist with the process and an additional software module for GIS information. If successful, the consultant and the software up to \$50,000 will be funded through this program. Upon completion of this project, we hope to be well along the asset management readiness scale. This will be an ongoing process to input new data regularly and to input information on condition of assets to be able to utilize this data. Staff training will also be required but the town allocates professional development funds in its operational budget.

This will also be a requirement of future Gas Tax Funding. Upon completion, Council will have the data to make decisions on projects they are considering and it will make the process more analytical.

The deadline for the application is July 14.

CAO read the motion that is required to apply for the funding.

Several years ago with the changes to the Public Sector Auditing guidelines, the Town had to start depreciating their assets. All equipment is on our system and all new projects are being added as they are completed. Other information on our previous projects is in the system, but further details are required.

If we are successful in obtaining funding, then we will hire a consultant. The Director of Operations and Public Works is continuing to collect data as we go and this will be an ongoing process. This provides for sustainability.
