

#### **Property Information:**


The property being sold by public tender is a parcel of vacant land located at 162 Water Street, Carbonear. This property is located in the downtown heritage waterfront area of Carbonear. The parcel of land is 404 m<sup>2</sup>.

The property is within the town boundaries and subject to applicable taxes. The property is currently zoned Heritage Area. The policies and uses for this zone have been attached to this document as well as the applicable section of the zoning map. A building is required to be developed on this lot within 24 months of the date of signing of the Purchase and Sale Agreement. If not developed within 24 months, the property is to be transferred back to the Town for 80% of the original purchase price. The Town will not be considering offers lower than \$20,000 for this tender. A Purchase and Sale Agreement is required to be signed within seven (7) days of the bid acceptance and the purchase transaction is required to be completed within 60 days of signing the Purchase and Sale Agreement. All development is subject to approval and issuance of a Development Permit by the Town of Carbonear and other required provincial and federal government departments and agencies, if applicable.
