Total tax revenue levied to date now exceeds the budgeted revenue by \$1,596. Expenditures for all departments are within budget. Transportation Services is

showing as 25% spent, however that is because this \$1.1million budgeted for asphalt which has not yet been invoiced.

- 3.) Carbonear Day Weekend was another great time. Unfortunately, our World Cup of Tiddly was affected by the weather. However, our first Co-Ed Softball Tournament was deemed a great success, as well as many of the other activities scheduled over the course of the weekend. Would like to thank our many volunteers and Special Events Committee for your hard work and dedication to that weekend!!
- 4.) Summer Concert (Rockin' Da Garden) is our next major event, happening on August 26<sup>th</sup>. Ticket sales have been going well and looking forward to a great evening with Shanneyganock and the Aldermen. Will also be hosting some local entertainment to get the night started.
