Whereas: About one in four children who are diagnosed with cancer will die of the disease; and

Whereas: Because of significant advances in therapy, 78% of children diagnosed with cancer will survive 5 years or more, an increase of almost 46% since the early 1960s

Whereas: Childhood Cancers have close to a 75% cure rate, with Leukemia leading the success charge with close to 90% overall cure rate.

Now Therefore the Town of Carbonear do hereby proclaim September 2023 as "Childhood Cancer Awareness Month" in the Town of Carbonear.

Councillor Noel questioned item 3a of the committee minutes. Not sure if this is completely accurate as the business was not invited. So that this is not complicated in the future, this should go to the Recreation Director and not to a volunteer of a softball organization. Anyone coming in on town facilities to use it to provide services, they need to know the process involved to obtain a permit to do so. Volunteers are hard to come by and we don't want to discourage volunteers from being involved. Councillor Noel noted that this was not an invitation to come and provide a service. rather it was a business that offered to provide a service. No individual company was asked to provide a service over another company. CAO advised this was a concern expressed by another company in the town and when the committee reviewed it, there was certainly no discussion about the volunteer organization itself. The committee will follow up further and in the future any vendor or business that goes on town property to provide goods or services, would go through the proper process to obtain a permit.
