7. Committee Reports

Public Works, Waste Management and Community Services

Deputy Mayor Slade advised the committee met on January 24, 2024.

Council can peruse the minutes.

There are not motions being recommended by the committee at this time. Deputy Mayor Slade read the following update to Council:

The committee has investigated concerns related to snow clearing of sidewalks and blue zone parking, specifically, those in the Heritage Waterfront District. This area has a significant number of store fronts along the sidewalks that depend on the sidewalks to access the buildings where these businesses are located and accessible parking for its customers. There have been operational amendments made by the Director of Operations and Public Works that does not impact snow clearing priorities but has improved the timeliness of the snow clearing of the sidewalks and accessible parking spaces in the Heritage Waterfront District. Town Streets are still the snow clearing priority. Businesses are required to maintain and complete snow clearing of accesses to its businesses. Snow clearing of a portion of the sidewalk may also be required to allow customer access until town staff have completed snow clearing of the town streets and are available to complete snow clearing of sidewalks. The sidewalks in the vicinity of the Carbonear General Hospital/Long Term Care Facility and the two schools on Valley Road are priority as well.

A Winter Maintenance Plan is being completed and a draft plan to be recommended by the committee is expected to be ready for Council's review and approval prior to the next Council meeting. This will provide specific guidance on winter maintenance operations.

Councillor Snow thanked the committee for their work on this matter.

b) Administration and Finance

Director will monitor the program and if there are very few participants during particular months, other programming can be considered during this time.
