- c) Economic Development, Planning and Land Use Development Councillor Doyle advised the committee met on March 6th. Councillor Doyle advised the following:
 - Staff are problem solving with resident who completed work prior to obtaining a permit.
 - Another development application is being deferred for when revised plan is received.
 - The MEO is in contact with an individual regarding application requirements.
 - Currently there is a development application that does not meet the requirements of the existing regulations, however if the new Plan and Development Regulations are approved and adopted, the application would meet the requirements.
 - Another application requires a Discretionary Use notice for a Home-Based business.
 - The upcoming March festival is already started. Lots of Paddy's day celebrations this weekend.

Councillor Doyle moved to the public gallery on the issue of the application for the proposed sober living home at 19 Industrial Crescent as she declared a conflict of interest on the matter because she is on the Board of Directors for an organization that is located in one of the properties that submitted an objection.

Councillor O'Grady advised that Council will proceed to set up a meeting with the applicants to get further information and clarification on the proposal.

After that Council will set up a public information session on the proposal.

Fire Chief Crawford thanked Council for their support of the Carbonear Volunteer Fire Department.

Chief Crawford noted that most of the calls are at the lights on Powell Drive and at the intersection near Shell on Powell Drive.
