#### 1. **Business Arising**

- a) Water Street Phase II, Limited call The draft is nearing completion and will be provided to the three consultants.
- b) 98 White's Road, non compliance to order A reminder letter that the town will be proceeding to court if no response by September 10 will be sent.
- c) 69 Southside Lower Road retaining wall on property Further investigation is required to determine whether the retaining wall is essential to town infrastructure. Deferred
- d) Highroad South paving, request update from the contractor The developer delayed a portion of the work as he intended to extend the water and sewer main. Contact will be made with the developer to determine the status of the situation.
- e) Underwater drone deferred for quote
- f) Update on watershed Water levels continue to decline. Staff reported that development of the contingency plan is underway and the Department of Environment has been informed.
- g) Department of Justice and Public Safety, Re: Permit for the installation of a Red Light and Siren on Fire Chief Private Vehicle from Fire Commissioner -Provincial approval has been received.

#### 3. Capital Works

LeMarchant Street Extension Water Sewer Storm and Road Upgrades, RE: Request for change order Installation of a ditch inlet and 1200mm catch basin at a cost of \$20,572.00. The committee will recommend. A draft motion will be prepared.

#### 4. Correspondence

Department of Transportation and Infrastructure, RE: Open call for a) applications 2026-2027 funding programs

- The deadline for submission is October 6. The committee felt priority should be given to pumphouse repairs. Staff will revise the list of potential projects for further discussion with Council.
- b) Foodcycle Science regarding food recycling program
  The committee had previously reviewed the food recycling program and it
  was not recommended to participate in the program since it was unlikely
  that residents would be prepared to pay the cost per unit. The committee
  is not recommending at this time.
- c) Property owner, Lemarchant Street Extension, inquiry on scope of project A response was provided to the property owner explaining the scope of work for the project is limited by the funds approved.
- d) Property owner, Grassey Lane, RE: Concern with driveway and water build up. This concern was forwarded along to the consultant who indicated the driveway was tied in accordingly and within construction tolerance. In the meantime, staff will monitor to see if a serious situation develops that needs to be addressed.
- e) Property owner, Valley Road, RE: Project materials in the neighbourhood. The storage of materials is temporary to supply the capital projects. It is located not to interfere with the dumping station. The property is also owned by the Department of Transportation and Infrastructure.
- f) Property owner, Crossroads, concern with water shut off / road closure Concern expressed that there was not sufficient notice during a recent water shut off. Email notifications were sent out through Carbonear Connect emails the evening before informing residents of the shut off and a notice placed on the Town's website. Notices are also sent out via the Town's Facebook account but it was learned later there were some technical issues that resulted in the notice not being posted to Facebook the evening before even though the post was prepared and set up to be posted. It was also noted the Contractors are advised to provide as much notice as possible. A response was provided to the property owner.
- g) Department of Fisheries, Forestry and Agriculture, RE: Forest Travel Permit Carbonear Municipal Water Supply
  The permit has been placed on file.
- h) Department of Municipal Affairs and Community Engagement, RE: Special Assistance Grant.

  A Special Assistance Grant in the amount of \$30,000, designed to provide emergency financial assistance to communities that meet specific criteria. It was noted that communities under a regional state of emergency are eligible to apply for this grant. The committee acknowledged this grant as an opportunity to help offset costs for piping and materials used in the watershed area. The town will submit any costs that are eligible under the grant.
- i) Newfoundland and Labrador Hydro, RE: EV Charging station NL Hydro is now accepting applications for Site Host to install EV charging stations. Carbonear has been identified as one of the locations. This would be at no cost to the town but the town would have to provide land.

The parking lot has been identified as a possible location. The committee discussed concerns with the loss of two parking spaces. It was noted that there would not be any loss of parking space just parking space for a different type of vehicle. The committee had no issue with this request; however, recommends having discussion with Council before the next Regular Council Meeting. A draft motion will be prepared.

j) Property owner, Cole's Lane, RE: Lemarchant Street Ext Project
The property owner is requesting to relocate the ditch on Cole's Lane
while contractors are working in the area. There is an easement on the
property for this drain and this is not within project scope.

a) Bulk Collection

The booking opens on Monday August 25 for bulk collection. Bulk collection is by appointment only with collection on October 10, 11, 14, 15, 16, 17, & 18. This will be advertised on social media, town website and Carbonear Connect.
